

## **Executive Report**

It has been a great year for Snowflake Place with memorable moments and events. We are pleased to highlight our many accomplishments and the great work that has been done over the last year.

The addition of two highly skilled child forensic interviewers to the core staffing component at Snowflake Place has expanded our operations and demand for services. These positions conduct child victim and witness interviews utilizing current and best practice child forensic interviewing techniques. They complement the investigative process through the provision of neutral, unbiased and high quality forensic interviewing that support criminal and child protection proceedings for child abuse cases. The integration of the forensic interviewers has enhanced our accessibility to young victims throughout Manitoba. The forensic interviewers have conducted 391 child interviews at Snowflake Place from January 2015 to June 2016.

Snowflake Place partnered with the University of Manitoba for the evaluation of our services from 2014 - 2016. A student of the Faculty of Community Health Sciences Graduate Program completed the evaluation as part of his thesis utilizing a mixed

methods approach and combined analysis of quantitative data tracked by Snowflake Place, and qualitative data from semi-structured interviews with 20 service providers and 10 service recipients (parents, foster parents, caregivers). The majority of service providers and service recipients described their overall experiences at Snowflake Place as being positive. Service providers identified that the integration of the forensic interviewers at Snowflake Place has increased the quality of service. An important finding of the evaluation is that the forensic interviewers facilitate communication among the multidisciplinary team which leads to more sharing of information, informal cross-training, and team unity. In addition, there were several service providers that credited the forensic interviewers for Snowflake Place's improvement in moving towards a true CAC model; although most expressed that true co-location would be necessary to achieve the ideal. The main contributing factor to a family having a positive experience was the amount of information they were provided in advance of the interview. Families reported they had a better understanding of the process and service providers at the Centre.

Over the past year we have dedicated a lot of time and energy toward building relationships with the broader community through an open house, networking opportunities, presentations, public speaking

and tours. Snowflake Place became a member of the Winnipeg Chamber of Commerce in April 2015. Our membership and relationship with the Chamber has helped us to become more known and recognized in the community. The opportunity to make connections with other non-profit and business organizations through luncheons, events, and speaking opportunities has been vital to helping us increase awareness in the community about the important work that we do. A very proud moment for us is the recognition we received as the recipient of the 2016 Spirit of Winnipeg Award in the Charity category. This award has raised our profile in the community and positioned us to build more partnerships as we go forward.

Throughout the year, a number of key officials visited Snowflake Place including the former Minister of Justice Gord Mackintosh, Mayor Brian Bowman and RCMP Assistant Commissioner Kevin Brosseau.

Snowflake Place has relied primarily on government funding to support our operations and services. We have generated some revenue through online donations and fundraising activities. As the need for our services continues to expand, we are mindful of the need to diversify revenue sources and secure more funding.

The Snowflake Place Board of Directors is committed to long-term sustainability and continued growth of the organization, a goal that has been identified in our strategic plan. Snowflake Place was awarded a community grant from The Winnipeg Foundation to engage with a professional fundraising consultant in development of a fundraising plan. Snowflake Place has partnered with the Creaddo Group resulting in a three-year fundraising plan that will help Snowflake Place raise revenue and strengthen fundraising capacity in the short-term and subsequent years. To allow for implementation of the plan and fundraising success, it is imperative that the Board and staff of Snowflake Place increase fundraising knowledge and practices and implement a concentrated program of activities focused on volunteer recruitment and donor solicitation as part of the organization's workflow. Additionally, we will continue to engage with our government partners for continued and long-term funding.

Snowflake Place was the recipient of the Winnipeg Foundation Youth in Philanthropy (YIP) grant in 2015 and 2016. Thank you to the Transcona Collegiate and Immigrant and Refugee Community Organization of Manitoba (IRCOM) YIP Committees for selecting Snowflake Place as a charity of your choice to receive this grant. This funding has helped to stock our vault and bring smiles to the faces of children and youth who come to Snowflake Place.

In closing, we are grateful to be a part of the important work that Snowflake Place is doing and the difference that we make to young victims and families. At Snowflake Place we strive to minimize the impact of victimization through innovation, collaboration and best practices. We cannot achieve the work we do without the care and expertise of our service partners and support from the community.

We also want to take this opportunity to offer a special thanks to our strong and diligent staff team. They are not only well respected and highly regarded among our service providers, but they have helped to improve relationships, enhance information sharing and break down barriers between stakeholders working with children and youth. We all know the consequences of child abuse are far reaching. The staff at Snowflake Place provide essential support critical to children and youth at a time in their life when many things are uncertain: their family situation, their future and their safety. We cannot underscore how appreciative we are of your dedication to children, youth and families in need.

Lastly, thank you to our Board of Directors for your guidance and leadership. We are proud of the excellent work that is being done at Snowflake Place and look forward to continued success in 2016 and 2017.

Snowflake Place for Children and Youth provides multi-system collaboration in child abuse investigations, ensuring that children, youth and their families receive support and services in a safe, neutral, family-friendly setting.

#### **Our Vision**

# Team of Professionals Working Together for Each Child

Police, child and family services and victim services come together at Snowflake Place to share information and coordinate roles and responsibilities in a central location to provide sensitive and immediate support to young victims and families.

# Advanced Practice by a Team of Professionals at Snowflake Place

High quality and best practice child forensic interviewing is a core service of Snowflake Place and a critical component in the investigation and prosecution of child abuse cases.

We have two dedicated forensic interviewers who specialize in child forensic interviewing and complement the investigation process through the provision of neutral, unbiased and high quality child forensic interviewing.

The forensic interviewers work collaboratively with police, victim services and child and family services to provide timely interviews, offer support and information to help families affected by abuse move forward.

The forensic interviewers coordinate the multidisciplinary team process at Snowflake Place to ensure that the service providers have the opportunity to share information and clarify their roles.

# Together We Are Building a Stronger Community — One Family at a Time

Snowflake Place for Children and Youth promotes the well-being of children and families through a coordinated response to child maltreatment and by supporting the work of organizations involved in child abuse investigations.

Snowflake Place for Children and Youth offers a central service approach for child victims of abuse. Partner agencies involved in child abuse investigations are able to engage with the child victim and their non-offending caregivers in one child-friendly location and provide supportive services.

# Snowflake Place Aims to Provide:

- A child-focused and child-friendly facility for child victims and their non-offending caregivers
- Support, guidance and information throughout the child abuse investigation and court process
- A multi-disciplinary team approach to child abuse investigations
- Best practice forensic interviewing techniques



# **Court Preparation** with Victims

Children and youth interviewed at Snowflake Place who are required to testify in criminal court proceedings all receive court preparation and court accompaniment by Manitoba Justice Victim Services. This is combined with meeting(s) with the Crown attorney to review evidence and provide further court preparation. Testimonial aids like closed circuit television, court screens and support persons are options considered to provide additional support at court. Proper court preparation and use of testimonial aids will increase children's familiarity with the Crown attorney and sense of control on this stressful day.


#### **Trauma Referrals**

Families are provided timely referrals to counselling by Victim Services staff immediately following interviews at Snowflake Place or as soon as practible; this may be to public resources in the community through application to the Compensation for Victims of Crime Program through Manitoba Justice Victim Services; the latter ensuring counselling for victims is covered with accessing private therapy.




# Who Have We Supported


### **Total Children and Youth Supported: 673**




#### Average Age: 9.4 Years



#### **Self-Identified Gender**




### **Self-Identified Ethnicity**
